**Pune:** The city-based metalsto-defence conglomerate Bharat Forge says that it has agreed to form a joint venture with the American electric mobility firm Harbinger Motors, through the former's Kalyani Powertrain Limited (KPTL), titled ElectroForge, which will focus on developing electric powertrains for commercial trucks.

The announcement comes days after Bharat Forge laid out a three-pronged plan to expand its EV offerings, including a focus on the trucking industry in global markets.
