Another Indian Artillery System to be Exported

Kalyani Strategic Systems announces\$155-million order from undisclosed customer for 155mm guns

New Delhi: After the sale of Pinaka multi barrel rocket launchers to Armenia, another Indian artillery system has secured export orders, with Kalyani Strategic Systems announcing a \$155-million deal from an undisclosed overseas customer.

The 155 mm artillery gun, which has been indigenously designed and manufactured, will be delivered to the friendly foreign nation over the next three years. The company has not disclosed the customer or the number of guns to be supplied but has said that the order is for a "non-conflict zone".

The company is, however, known to have sent its 155 mm guns for trial evaluation to the Royal Saudi Army in 2020. At least two types of guns sent by



the company were tested in the Saudi Arabian deserts. Kalyani also has a truck mounted artillery system on offer called the MArG 155mm/39 caliber.

The Indian Army is yet to place an order with the company for any of its artillery system but is currently evaluating the Defence Research and Development Organisation (DRDO) origin ATAGS gun, prototypes of which have been made by Kalyani and Tata Advanced Systems.

As reported, the first-ever export of indigenous artillery systems took place in September, with Armenia placing an order for the Pinaka multi barrel rocket launchers (MBRL), supplies for which are to be executed majorly by private sector companies.



Bharat Forge is becoming a bigplayer in artillery gun systems, along with Tata Advanced Systems. Both companies are working with the Defence Research and Development Organisation in developing the indige-nous Advanced Towed Artillery Gun System, a 155 mm. 52-calibre howitzer that is significantly heavier, more powerful, and has a longer range than the MGS. This order will have a significant impact on the growth of overall defence exports. The government had stated in the Rajya Sabha on February 10, 2020, that India's defence exports had grown sevenfold in two years - from ₹1,522 crore in 2016-17 to ₹10,746 crore in 2018-19.

According to a target set by MoD in the Defence Production Policy of 2018, the annual defence exports are to grow to \$5 bil-lion by 2023.

Kalyani Strategic Systems Ltd, a wholly-owned subsidiary of Bharat Forge, has got an export order for 155 mm artillery gun system worth \$155.50 million.

Though the company did not reveal the name of the country to which it would be exporting the artillery gun systems, Kalyani Strategic Systems Ltd said the order will be executed over three years.

"This order, to a non-conflict zone, is a great testament to the Government of India's Aatma Nirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India," the company said in a BSE notification.

Bharat Forge is scaling up

its capabilities in defence systems as in the past it exported armoured personnel carrier and armoured troop carrier.

At the recently concluded DefExpo 2022, Bharat Forge unveiled 'MGS 8x8', a 155 mm/52 calibre mounted artillery gun system that is equipped with quick shootand-scoot capability with a high degree of accuracy and consistency.

In a major success for Indian firm Kalyani Strategic Systems Limited on Wednesday announced receiving an order worth USD 155 million for supplying howitzers.

However, the Baba Kalyani-owned company did not disclose the buyer except for clarifying that it was in a non-conflict zone.

"We are pleased to inform that Kalyani Strategic Systems Limited, a wholly-owned subsidiary of the Company, has been awarded an export order for a 155mm Artillery Gun platform to be executed over a 3-year timeframe. The total value of the order is USD 155.50 million," the company said in a statement.

"This order, to a non-conflict zone, is a great testament to the Indian government's Aatmanirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defense platforms from India," it said.

Kalyani is one of the major investors in the defense sector and has been offering a number of weapon systems to India as well as foreign countries.

The company has been working with Defence Research and Development Organisation (DRDO) to develop the advanced tower artillery gun system (ATAGS) and has also developed an ultra-light howitzer.

The Prime Minister has also urged the defence industry to develop its products for the global market and achieve USD 5 billion targets by 2025.

Leading defence manufacturer Bharat Forge on Wednesday said its subsidiary Kalyani Strategic Systems Ltd has secured an export order worth USD 155 million for a 155mm artillery platform.

Without providing the details of the customer, the company said the order is for a "non-conflict zone" and that it is a "great testament" to the government's 'Aatma-Nirbhar Bharat' (self-reliant India) agenda.

"We are pleased to inform that Kalyani Strategic Systems Ltd, a wholly- owned subsidiary of the company, has been awarded an export order for a 155mm artillery platform," Bharat Forge said in a statement.

It said the order will be executed over a three-year timeframe.

"The total value of the order is USD 155.50 million. This order, to a non-conflict zone, is a great testament to the government of India's Aatma Nirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India," the company said.

The defence ministry has set a goal of a turnover of USD 25 billion (Rs 1.75 lakh crore) in defence manufacturing in the next five years that included an export target of USD 5 billion (Rs 35,000 crore) worth of military hardware.

In the last few years, the government has taken a series of measures to promote domestic defence production.

Bharat Forge has expertise in design, development, engineering and manufacturing in systems and subsystems space for artillery guns, armoured fighting vehicles, protected vehicles, ammunition, defence electronics and small arms among others.

Last month, Bharat Forge Ltd signed an agreement with American technology major General Atomics for collaboration in developing Lithium-Ion battery system for use by the Indian Navy.

After the sale of Pinaka multi barrel rocket launchers to Armenia, another Indian artillery system has secured export orders, with Kalyani Strategic Systems announcing a \$155-million deal from an undisclosed overseas customer.

The 155 mm artillery gun, which has been indigenously designed and manufactured, will be delivered to the friendly foreign nation over the next three years. The company has not disclosed the customer or the number of guns to be supplied but has said that the order is for a "non-conflict zone".

The company is, however, known to have sent its 155 mm guns for trial evaluation to the Royal Saudi Army in 2020. At least two types of guns sent by the company were tested in the Saudi Arabian deserts. Kalyani also has a truck mounted artillery system on offer called the MArG 155mm/39 caliber.

The Indian Army is yet to place an order with the company for any of its artillery system but is currently evaluating the Defence Research and Development Organisation (DRDO) origin ATAGS gun, prototypes of which have been made by Kalyani and Tata Advanced Systems.

As reported, the first-ever export of indigenous artillery systems took place in September, with Armenia placing an order for the Pinaka multi barrel rocket launchers (MBRL), supplies for which are to be executed majorly by private sector companies.

In fact, Indian private sector companies have been leading when it comes to defence exports, though public sector units still outmatch them when it comes to annual production of military systems. According to defence ministry data, 70% of India's exports worth close to ₹13,000 crore in the last financial year were done by private companies.

There has been a sustained effort to increase defence exports, with several new policy initiatives and active assistance of Indian overseas missions. The government has set a target to achieve exports worth \$5 billion annually by 2025 and counts it as a priority area, with several rounds of seminars and special events being conducted for prospective customers. In the recently conducted DefExpo in Gandhinagar too, foreign military delegations from Africa and Indian Ocean Region countries were invited and showcased the breadth of military equipment on offer.

Bharat Forge has been consolidating its defence and aerospace business under Kalyani Strategic Systems with an aim to target export opportunities in the defence sector.

In FY22, the company produced Kalyani M4 armoured vehicles for the Indian Army for the UN Peacekeeping mission.

Since 2021, the defence ministry has been announcing a staggering ban on the imports of several weapons with an aim to encourage production and export.

"This order, to a non-conflict zone, is a great testament to the Government of India's Aatmanirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India," the filing added.

In a deal worth \$155 million (over Rs 1,200 crore) Pune-based Kalyani Strategic Systems, a wholly-owned subsidiary of the Company has bagged an order from a non-conflict country for its indigenous 155mm Artillery Gun platform.

In a notification to Bombay Stock Exchange (BSE) the Kalyani Group has specified that the order is from a Non-Conflict Zone and it will be executed over a period of three years.

According to a company note this deal with a country in a non-conflict zone is a testament to India's push on exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India as well as `Atmanirbhar Bharat' agenda.

Though the company has not specified which country, but Kalyani Group has in a notification to BSE i.e. Bombay Stock Exchange stated that Kalyani Strategic Systems has been declared as a 'Non-Conflict Zone'.

What is a non-conflict zone?

It means that the order is from a country whose geo-location is nowhere located in a war zone.

Where could this be?

According to sources, in 2020, the Kalyani Group had sent two Bharat 52 a 155mm, 52 caliber towed howitzer for trials to Saudi Arabia. Though the company notification has not mentioned the specific country, industry sources have indicated that the towed guns could be going to the Kingdom of Saudi Arabia. There is also no clarity on which artillery system is being exported and how many.

Saudi Arabia has already carried out trials in extreme temperatures of Bharat Forge's Bharat 52, a 155 mm, 52 caliber towed howitzer. This is the first gun which has been manufactured by an Indian private sector company and has a range of about 41 kms and has the capability to fire six rounds in 50 seconds.

As reported earlier, the company is also making the indigenous 'ATAGS' (Advanced Towed Artillery Gun System) for the Indian Army. And earlier this year on the occasion of the Independence Day on August 15, it was this same gun which was used for giving the 21-gun salute from the Red Fort. The ATAGS has been developed in partnership with the Defence Research and Development Organisation (DRDO)

Apart from this, the M-4 Combat Vehicle of the Kalyani Group has been purchased by the Indian Army for the movement of troops on the Line of Actual Control (LAC) close to China in Eastern Ladakh.

What is the difference between ATAGS and Bharat 52?

The ATAGS which has cleared the Army's firing trials is undergoing metallurgical tests and it has a firing range of 48 kms. As reported earlier in Financial Express Online this gun has other advanced features including advanced communication system; high mobility, quick deployability, auxiliary power mode, automatic command and control system and more.



Officials have earlier confirmed to Financial Express Online that compared to other gun systems of the same caliber globally, this is accurate and has consistent systems. The ATAGS, which has cleared the Indian Army's firing trial, is currently under metallurgical tests.

The company has other gun systems of 155 mm, including the Ultra Light Howitzers and Mounted Guns.

Defence export is rising. Indian defence entities secured two mega orders—BrahMoS missile and Artillery Gun Platform. But there requires a cohesive policy thrust to achieve the ambitious target by 2035.

India stands at fourth position among 12 countries of the Indo-Pacific in self-reliant defence production, which is based on the reports published by the Stockholm International Peace Research Institute (SIPRI). India's defence exports reached to Rs 13,000 crore in the Financial Year 2021-22 (FY22). While China surged ahead in the list, making rapid stride in the list.

It is estimated that the value does include the Rs 2,770 crore contract in January this year to export BrahMoS supersonic missiles to the Philippines.

Building upon the breakthrough, Kalyani Strategic Systems Limited, a wholly-owned subsidiary of the Company, has been awarded an export order for a 155mm Artillery Gun platform to be executed over a 3-year timeframe. The total value of the order is \$ 155.50 Million.

This order is to a non-conflict zone, is a great testament of the capabilities shown by the private defence company. The result is defiantly the outcome under the sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India.

Defence minister Rajnath Singh has emphasized many time that India will target annual defence exports of Rs 35,000 crore by the end of FY 2025. But the most ambitious is the plan where India will strive to be amongst top five countries globally in defence production in the next 25 years.

The global arms export

Ironically, while India relied heavily on the defence import, there was hardly any direction or set benchmark target for the defence export until the launch of Defence Production Policy.

The Defence Production Policy (DPrP) 2018 came out of bolt. In a first, DPrP set the direction to achieve 35,000 crore (\$5 billion) by 2035.

The world of defence export is heavily based on the cutting-edge research and development for the everchanging nature of conflicts which demand next generation technological base. That is more towards the scale of production based on precision in-line set up to be able to deliver on time.

It is important to note that the Indian defence industry is still in the phase that primarily aims to cater the Indian Armed Forces.

Despite the constraints, it is pertinent to highlight those exports reached a high of Rs 13,000 crore in 2021-22. While the number is derived on low-base, it is still a significant growth by any yardstick.

But the larger question is about the next cycle of growth in defence export. Simply to put it straight, to achieve the \$ 5 billion export mark, India needs a three-fold increase for meeting the DPrP-2018 export target.



How the global arms industry works?

The majority of defence purchase is confined among few global entities which make the 80 percent of total sales worldwide. According to the Sweden-based Stockholm International Peace Research Institute (SIPRI), U.S., Russia and France accounted for 69 percent of the global exports at 39 percent, 19 percent and 11 percent respectively. Again, while China is still not in the top, it is reaching fast. According to the senior defence analyst, the reason that China is still catching up, is due to its own domestic demand and the constant upgradation under the modernization drive. Along, there is no doubt that China has almost achieved the industrial capabilities to match the scale of production with full range of military platforms and systems across the domains. Overall, China's share in global arms is about 6 percent and it does include heavy platforms/equipment, including combat jet.

In the ranking, India stands at the bottom with Czechia and Jordan where the private sector companies accounted for 70 per cent of these exports.

About 50 Indian companies in the private sector have contributed to defence exports. Some of the major export destinations for defence products have been Italy, Maldives, Sri Lanka, Russia, France, Nepal, Mauritius, Sri Lanka, Israel, Egypt, UAE, Bhutan, Ethiopia, Saudi Arabia, Philippines, Poland, Spain and Chile etc. The major defence items being exported are Personal Protective items, Offshore Patrol Vessels, ALH Helicopter, SU Avionics, Bharati Radio, Coastal Surveillance Systems, Kavach MoD II Launcher and FCS, Spares for Radar, Electronic System and Light Engineering Mechanical Parts etc.

In the first tranche, India has cleared 156 defence equipment for exports including the indigenous Light Combat Aircraft Tejas, artillery guns, battle tanks and missiles, anti-tank mines and explosives.

Defence export policy

The defence export has taken off but how does the policy work around the process? Ministry of Commerce & Industry already has an overall Export Policy in the form of Foreign Trade Policy (FTP), which, inter-alia, includes various export promotion schemes, duty/ tax exemptions and other facilitative measures. According to the Ministry of Defence, therefore, there may not be a need for having a separate Defence Export Policy.

So, the policy revolves around supporting industry in Testing and Certification. In case of private entities, it offers the military infrastructure and labs under DRDO. While this is a god step in the direction, the export of military equipment does demand international certification and testing. That poses challenges in the final cost evaluation in the competitive global market.

Lines of Credit for Defence

The Ministry of External Affairs has been granting various Lines of Credit to the friendly foreign countries. While this remains underutilized, there are some good examples where industry has worked around.

Recently, India handed over 12 High Speed Guard Boats to Vietnam. The boats have been constructed under the Government of India's \$ 100 million Defence Line of Credit to Vietnam. The initial five boats were built in the Larsen & Toubro (L&T) Shipyard in India and the other seven in Hong Ha Shipyard. Senior civil and military officials of India and Vietnam were present during the handing over ceremony.

Use of Offset Policy



Offset is an important mechanism available to the domestic industry to enhance export capability. The Offset Policy may be reviewed and aligned towards final integration of weapons/systems in India and promoting export of such systems from India. The Policy may also be reoriented towards acquisition of critical technologies required for high end weapons/platforms so that the same can be leveraged for export.

The jump in exports to the US could possibly be due to the MoD pressing upon the US companies to make up the chronic shortfall in fulfilling their annual offset targets for previously imported equipment. Revenue earned by the Indian companies would diminish once these offset contracts are completed.

Issue No Objection Certificate

Presently export of defence equipment and weapons is regulated by two Departments. For items contained in the SCOMET list of Foreign Trade Policy of DGFT, export licences are granted by DGFT based on the Inter-Ministerial Working Group set up in DGFT. Ministry of Defence is one of the members in the Inter-Ministerial Working Group. For military stores, No Objection Certificate (NOC) is issued by the Department of Defence Production. The procedure for issuing the NOC in case of military stores has not been put in the public domain due to non-availability of list of military stores.

That requires a cohesive approach, said an industry veteran. Such compliance is necessary but it needs to be brought under the umbrella, he added. It takes time. With further push, India might achieve its objective towards defence export.

Guns to be delivered to "non-conflict country" in three years under Government-to-Government deal.

Bharat Forge subsidiary Kalyani Strategic Systems has announced a \$155.5 Million export contract for its 155 mm, 39 calibre truck-mounted artillery guns.

This is first artillery export order for an Indian company, and the country's second-largest export order for military equipment after the \$375 Million BrahMos supersonic cruise missiles contract signed with the Philippines in February 2022. It comes amidst India's drive to push up Defence exports to \$5 Billion by 2025.

"We are pleased to inform that Kalyani Strategic Systems Limited, a wholly-owned subsidiary of the Company (Bharat Forge Ltd), has been awarded an export order for a 155mm Artillery Gun platform to be executed over a 3-year timeframe. The total value of the order is USD 155.50 Million," Bharat Forge announced on November 9.

"This order, to a non-conflict zone, is a great testament to the Government of India's AatmaNirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India," the statement added.

The Bharat Forge statement did not specify the country which awarded Kalyani Strategic Systems the contract nor did it elaborate on the type of the 155 mm artillery gun platform ordered. But BW Businessworld has learnt from reliable sources that it is the truck-mounted 155 mm, 39 calibre gun which has been contracted by the unnamed country under a Government-to-Government deal with India.

Kalyani's truck-mounted gun goes by the moniker MArG - the Multi-terrain Artillery Gun. It is also called the 155 – BR, which the Bharat Forge group claims is the world's first truck-mounted 155/39 howitzer. The 18-ton gun is mounted on a 4x4 high-mobility vehicle. Earlier, the heaviest gun mounted on a truck was a 105 mm gun. A shoot-and-scoot weapon, the 155 – BR has the capability to operate in rugged mountainous terrain.

The mounted howitzer's sustained rate of fire is 42 rounds in 60 minutes, an intense rate of 12 rounds in 3 minutes and a burst rate of 3 rounds in 30 seconds.

Bharat Forge is developing a range of artillery systems with the intention of becoming the world's largest artillery gun manufacturer. Leveraging its competence in metallurgy, the group has made a foray into the Defence sector with indigenously designed and developed artillery guns, armoured fighting vehicles and protected vehicles as its marquee products.

Incidentally, the company is awaiting its first order by the Indian Army for artillery guns. Bharat Forge and Tata Power SED are the development and production partners for the Defence Research and Development

The company has neither revealed the name of the foreign customer nor the number of guns to be delivered. "This order, to a non-conflict zone, is a great testament to the government's Aatmanirbhar Bharat (self-reliant India) agenda and its sustained push to promote exports of indigenously designed developed and manufactured (IDDM) advanced defence platforms from India," the company informed the Bombay Stock Exchange on Wednesday.

Kalyani Strategic Systems will execute the order over the next three years. The firm was in talks with Saudi Arabia for the possible sale of its Bharat 52 155mm/52-calibre artillery gun, HT has learnt.

The development comes when India has sharpened its focus on getting a toehold in foreign markets, set a target of achieving defence exports worth \$5 billion by 2025, and taken a raft of policy measures to boost the indigenous defence manufacturing sector. It also comes on the back of the Philippines ordering BrahMos missiles and Armenia choosing to buy Pinaka multi-barrel rocket launchers from India.

India has clocked defence exports worth ₹30,000 crore since 2014 after the Narendra Modi government came to power, with the first six months of the current financial year alone accounting for export orders worth ₹8,000 crore, officials said. India's defence exports reached their highest level in 2021-22, with the figure hitting ₹13,000-crore mark and the private sector accounting for 70% of the exports, an outcome of the government's policies to boost the export of military hardware to friendly foreign countries.

Military hardware being exported by India include missiles, the advanced light helicopter, offshore patrol vessels, personal protective gear, surveillance systems, and a variety of radars, the officials said.

In January, India's BrahMos Aerospace and the Philippines signed a deal worth almost \$375 million for the Philippine Marines to acquire three batteries of the BrahMos cruise missile, a shot in the arm for New Delhi's efforts to emerge as an exporter of major defence hardware.

The military hardware that holds export potential includes the light combat aircraft, Astra beyond-visual-range air-to-air missile, Akash surface-to-air missile system, tanks, sonars, and radars.

India has also imposed a phased import ban on 411 different weapons and systems during the last two years to provide a boost to the indigenous defence manufacturing sector. These weapons and platforms are expected to be indigenised in phases over the next five to six years.

In December 2020, the Union Cabinet, headed by the Prime Minister, gave its go-ahead to the sale of Akash missile systems to friendly foreign countries, and also created a high-powered panel for swifter approval of defence exports.



"India has a good strategy and action plan in place, backed by forward-looking policies, to ensure self-reliance in defence, and boost the country's status as a net exporter of weapons in the coming years," military affairs expert Lieutenant General Vinod Bhatia (retd) had earlier said.

The government granted close to a thousand export authorisations last year, nearly four times the number approved five years before that, and cut down the time for such approvals by a third between 2017 and 2021.

Defence minister Rajnath Singh earlier asked the Indian defence industry to step forward and manufacture modern and cost-effective defence products to realise the government's vision of a 'New India' that can not only meets its own needs but also fulfill the requirements of other countries.

In a first, a Pune-based private defence manufacturing company has bagged an export order worth Rs 1,266 crore (\$155.5 million) to supply an unspecified number of 155 mm artillery gun systems to a country whose identity has not been disclosed.

"Kalyani Strategic Systems Limited, a wholly-owned subsidiary of Bharat Forge Ltd has been awarded an export order for a 155 mm Artillery Gun platform to be executed over a 3-year time frame. The total value of the order is \$155.5 million," the company disclosed in a regulatory filing.

"This order, to a non-conflict zone, is a great testament to the Government of India's Atma Nirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured advanced defence platforms from India."

Even though the identity of the recipient was not disclosed, Saudi Arabia is speculated to be the recipient because the Middle-Eastern nation in 2020 had conducted trials of Bharat-52, a 155 mm, 52-calibre towed howitzer, which was the first artillery gun manufactured by the defence firm led by Baba Kalyani. It has a range of about 40 km and is capable of firing six rounds in 50 seconds.

The Kalyani Group has multiple versions of 155 mm artillery guns including the ATGS (advanced towed artillery gun system), which was developed in collaboration with the Defence Research and Development Organisation (DRDO) for the Indian Army. The ATGS has not been inducted into the Indian Army as it is still under testing.

This is the second major defence export from India within the last two months, but the first big one from the private sector. Earlier in September, a government-to-government contract was closed between India and Armenia for the supply of Pinaka multi-barrel rocket launchers. The Pinaka order, believed to be a \$250 million contract, is to be executed within the next two years.

India's defence exports have grown over the years, from less than Rs 900 crore in 2014 to over Rs 13,000 crore now. The Defence Ministry has set a target of Rs 1.75 lakh crore of defence production by 2025, which includes exports of Rs 35,000 crore.

Under the export order worth \$155 million, the Kalyani Group will supply an unknown number of 155mm artillery guns in three years.

The announcement comes just weeks after the conclusion of the 2022 Defexpo in Gandhinagar, where Baba Kalyani, Chairman of Kalyani Group, said that the company would set up the world's largest artillery manufacturing facility in India. The new plant, he said, would produce one artillery gun a day. The company currently builds six guns in 30 days.

"We [the Kalyani Group] are in the process of setting up the world's largest artillery manufacturing capacity. In three years from now, we will produce one gun per day," Kalyani has been quoted as saying.

Bharat Forge, a subsidiary of the Kalyani Group, has recently supplied M4 armoured vehicle to the Indian Army. Kalyani's M4 is a license-built version of Mbombe 4 developed by South Africa's Paramount Group.

The Advanced Towed Artillery Gun System or ATAGS, a 155-mm, 52-calibre artillery gun currently undergoing trials, has been jointly developed by the Defence Research and Development Organisation with Bharat Forge of the Kalyani Group and the Tata Advanced Systems Limited.

The deal comes at a time when the Narendra Modi government has set a target to achieve defence exports worth \$5 billion and an overall turnover of \$22 billion in production by 2025.

In 2021-22, India exported defence equipment worth \$1.59 billion or 13,000 crore. The country has registered defence exports worth Rs 8,000 crore in six months of the current financial year.

However, the company didn't mention the country which has placed the order for the artillery guns but mentioned that it is a non-conflict zone, which means that the country is currently not involved in any war. The company said, "This order, to a non-conflict zone, is a great testament to the Government of India's AatmaNirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India."

The company also didn't specify the exact artillery being exported, as Kalyani Strategic Systems makes multiple models of 155mm gun, which are MArG (Multi-terrain Artillery Gun), Bharat ULH (Ultra-Light Howitzer), Bharat 52 and Bharat 45.

The purchaser country could be Saudi Arabia and the selected gun could be Bharat 52, as it was reported in 2020 that Saudi Arabia was evaluating two guns sent by Kalyani Group, Bharat 52 and Garuda V2. As Garuda V2 is a 105mm gun, it is not the gun in question. Bharat-52 gun is a 155mm, 52 calibre towed howitzer, and it is also being considered by the Indian Army.

A variety of goods, including a variety of artillery weapons, have been manufactured by Bharat Forge, which has recently extensively diversified into the production of defence equipment. While it has supplied the Indian Army with 60 Kalyani-M4 armoured vehicles and has orders for 30 more, it has not yet received a domestic order for its artillery cannons.

The defence ministry has been gradually banning the import of a number of weapons since 2021 in an effort to boost manufacturing and export. Bharat Forge's shares reached a 52-week high of Rs. 890 on the BSE after the announcement, before dropping to Rs. 878.7 on Wednesday.

It is notable that this is the second such big incident in which an Indian defence manufacturer has received an order for exports. In September 2022, India received an order to export missiles, rockets, and ammunition to Armenia. India is also going to export the indigenous Pinaka multi-barrel rocket launchers to Armenia to aid the nation in its war against Azerbaijan. It will be the first export of the Pinaka rocket launchers.



India has signed a \$250 million (over Rs 2000 crore) deal to export anti-tank rockets and other ammunition to Armenia, apart from the rocket launchers. India will be supplying the weapons in the coming months via a government-to-government channel.

In an unprecedented breakthrough in indigenous weapons systems exports, Pune-based Bharat Forge announced on Wednesday that Kalyani Strategic Systems – a wholly owned subsidiary – "has been awarded an export order for a 155 millimetre (mm) artillery gun platform to be executed over a three-year timeframe."

"The total value of the order is USD 155.5 million," stated a company media release. That amounts to approximately Rs 1,265 crore – more than one-tenth the value of India's annual defence exports in each of the last two years.

Bharat Forge has neither announced the name of the buyer country, nor the type of gun being exported. However, Ministry of Defence (MoD) sources have confirmed that the buyer country is Armenia and the order consists of 155 mm, 39 calibre howitzers that are mounted on trucks for mobility.

Sources in the MoD say that the order has been made public only to conform to Security and Exchange Board of India (SEBI) regulations that demand the publication of information that is likely to affect stock prices.

Bharat Forge had its board meeting on Wednesday.

At the price that Bharat Forge has divulged, the Armenian order will involve the purchase of four-to-five regiments of 155 mm mounted gun systems (MGS). Each regiment consists of 18-20 guns.

"This order, to a non-conflict zone, is a great testament to the Government of India's Aatmanirbhar Bharat agenda and its sustained push to promote exports of indigenously designed, developed and manufactured (IDDM) advanced defence platforms from India," stated the Bharat Forge press release.

Bharat Forge is becoming a big player in artillery gun systems, along with Tata Advanced Systems Ltd (TASL). Both companies are working with the Defence Research and Development Organisation (DRDO) in developing the indigenous Advanced Towed Artillery Gun System (ATAGS), a 155 mm, 52 calibre howitzer that is significantly heavier, more powerful and has a longer range that the MGS.

This order will have a significant impact on the growth of overall defence exports.

The Government has stated in the Rajya Sabha (the upper House of Parliament) on February 10, 2020 that India's defence exports have grown seven-fold in the last two years from Rs.1,522 crore in 2016-17 to Rs.10,746 crore in 2018-19.

According to an analysis by Business Standard, the value of authorization/ licences issued by the Department of Defence Production to private companies, and actual export by defence public sector undertakings (DPSUs) and the Ordnance Factory Board (OFB), the value of defence exports during preceding years has grown as shown in the graphic.

According to a target set by the MoD in the Defence Production Policy of 2018, annual defence exports are to grow to \$5 billion by 2023.

On ninth November 2022, Bharat Forge Limited, an organization positioned in Pune, stated that it has acquired a \$155.50 million export order for one in all its 155mm artillery gun platforms. The contract had been acquired by its subsidiary Kalyani Strategic Systems Limited, and it might be accomplished in three years.

The Atmanirbhar Bharat initiative by the federal government of India and the Make in India coverage has introduced a big change within the defence manufacturing sector of India, and it is likely one of the examples of the success of the initiative.

The firm communicated with the Bombay Stock Exchange in a notification that stated, "We are pleased to inform that Kalyani Strategic Systems Limited, a wholly-owned subsidiary of the Company, has been awarded an export order for a 155mm Artillery Gun platform to be executed over a 3-year time frame. The total value of the order is \$155.50 million."

However, the corporate didn't point out the nation which has positioned the order for the artillery weapons however talked about that it's a non-conflict zone, which signifies that the nation is at the moment not concerned in any conflict. The firm stated, "This order, to a non-conflict zone, is a great testament to the Government of India's AatmaNirbhar Bharat agenda and its sustained push to promote exports of Indigenously Designed Developed and Manufactured (IDDM) advanced defence platforms from India."

The firm additionally didn't specify the precise artillery being exported, as Kalyani Strategic Systems makes a number of fashions of 155mm gun, that are MArG (Multi-terrain Artillery Gun), Bharat ULH (Ultra-Light Howitzer), Bharat 52 and Bharat 45.

The purchaser nation could possibly be Saudi Arabia and the chosen gun could possibly be Bharat 52, because it was reported in 2020 that Saudi Arabia was evaluating two weapons despatched by Kalyani Group, Bharat 52 and Garuda V2. As Garuda V2 is a 105mm gun, it isn't the gun in query. Bharat-52 gun is a 155mm, 52 calibre towed howitzer, and it's also being thought-about by the Indian Army.

In a first for the country, India's private defense player Kalyani Strategic Systems has bagged a \$155 million (over Rs 1,200 crore) export order for artillery guns from an undisclosed country.

In a regulatory filing, Bharat Forge, part of the Kalyani Group, said the order is for "non-disputed territory". The company also said orders for the 155 mm artillery gun platform should be processed over a three-year period.

The company did not specify which artillery systems were being exported and what the quantity was. However, industry sources indicated that the order could be for a Middle Eastern nation.

Remember that Saudi Arabia had tested Bharat 52, 155 mm, 52 caliber tod howitzer of Bharat Forge. Sources said that the weapon was tested by the Saudi Army in 2020. It was the first artillery gun produced by the defense firm and it has a range of 41 km and is capable of firing 6 rounds in 50 seconds.

The Kalyani Group has several variants of 155mm artillery guns, including the Advanced Towed Artillery Gun (ATAGS) developed in partnership with the Defense Research and Development Organisation.

The difference between Bharat 52 and ATAGS is that the latter has a higher firing range as well as rate of fire, in addition to mobility and other technical aspects. ATAGS, which has cleared the firing test of the Indian Army, is currently undergoing metallurgical testing.

In addition to the Bharat 52, the Bharat Forge has several 155 mm gun systems, including mounted guns and ultralight howitzers.

Another order for India's artillery system

The order received by Bharat Forge is the second for India's artillery system. Earlier this year, the country received an order for Panaka multi-barrel rocket systems from Armenia under a government-to-government route.

The Kalyani Group, however, is yet to receive orders from the Indian Army for its artillery systems.

The Indian Army is currently implementing a Field Artillery Rationalization Program (FARP), which was conceived in 1999. Under FARP, the Army was to have a mix of around 3,000-3,600 155 mm guns by 2025-27, but of different caliber guns., mounted, self-propelled (track and weld) howitzers.

This should be achieved through a combination of direct importation, licensed production and indigenous systems.

Kalyani Strategic Systems will fulfill this order in the next three years. The firm was in talks with Saudi Arabia for a possible sale of the India 52 155mm/52-caliber artillery gun, HT has learned.
