# India bans import of 101 defence equipment

To create domestic manufacturing of ₹4 trillion in next six to seven years

nvoking the Prime Minister Narendra Modi's Atmanirbhar Bharat (Self-Reliant India) initiative, the Ministry of Defence (MoD) announced on Sunday a phased, year-wise embargo on the import of 101 items of defence equipment. As an equipment type comes under the import embargo, the military will be required to buy it from Indian defence manufacturers.

"This decision will offer great opportunity to the Indian defence industry to manufacture items on the negative list by using its own design and development capabilities or adopting the technologies designed and developed by the Defence R&D Organisation to meet the requirements of the Armed Forces," tweeted Defence Minister Rajnath Singh.

Modi endorsed the new export embargoes from his own Twitter account shortly afterwards.

"The embargo on imports is planned to be progressively implemented between 2020 and 2024. Our aim is to apprise the Indian defence industry about the anticipated requirements of the Armed Forces, so that they are better prepared to realise the goal of indigenisation," said Rajnath. Starting from December, the military will

Starting from December, the military will rely exclusively on indigenous vendors for 69 categories of defence equipment, including self-propelled and towed artillery guns, multi-barrelled rocket launchers, bulletproof jackets and helmets, several types of warships, light transport aircraft, light combat fighter aircraft, light combat helicopters, and ground transport vehicles. With effect from December 2021, the military will have to buy another 11 types of equipment, including wheeled tanks, light machine guns, assault rifles, and conventional submarines from Indian manufacturers. Another 21 categories of equip-ment would have to be sourced only from Indian suppliers from cut-off dates ranging from December 2022 (four equipment types), December 2023 (eight types), and December 2024 (eight types). Additionally, the MoD has mandated that long-range cruise missiles must be bought from indigenous suppliers from December 2025 onwards. The MoD gave three examples of "highly complex weapons platforms" on the list of 101 embargoed items, which add up to ₹1.32 trillion. The Army will buy 200 wheeled armoured fighting vehicles for over ₹5,000 crore, since their import is embargoed after December 2021.

With the import of submarines embargoed after December 2021, the Navy will contract six for approximately ₹42,000 crore. The Air Force will buy 123 Tejas fighters for ₹85,000 crore, since their import is banned after December. Rajnath tweeted that in the five years between April 2015 and August 2020, the military bought equipment worth ₹3.5 trillion in these 101 categories. He estimated that, within the next six to seven years, contracts worth almost ₹4 trillion will be placed upon the domestic industry.

"Of these, items worth almost ₹1.3 trillion each are anticipated for the Army and
the Air Force, while items worth almost

The Indian industry on Sunday welcomed the defence ministry's move to stop import of 101 defence items in a phased manner, beginning December 2020, with one representative describing it as a "new glide path" for "AtmaNirbhar Bharat".

In his remarks, Chandrajit Bannerjee, director general of the Confederation of Indian Industry (CII) lobby group welcomed the negative list and the announcement that ₹52,000 crore would be earmarked for procurement from domestic manufacturers.

"The defence minister's announcement for negative import list of defence systems and platforms marks the launch of a 'new glide path' for 'AtmaNirbhar Bharat'," he said.

"The announcement of ₹52,000 crore for domestic capital procurement coupled with the list of 101 items for import embargo gives a tremendous boost to AtmanirbharBharat and indigenous defence manufacturing...We can assure the Defence Minister that the Indian Defence and Aerospace industry will rise to the Challenge and opportunities," Bannerjee added.

In a separate statement, Baba Kalyani, chairman and managing director of Bharat Forge, a leading forging company, said Sunday's announcements were a strategic step that will "propel the Atmanirbhar Bharat narrative and bolster Indian defence equipment manufacturing industry".

"The growth of the domestic industry especially the MSME sector, will lead to self-reliance, reduced expenditure on imports, saving of foreign currency, creating job opportunities, revival of consumption and ultimately getting us closer to the common goal of 5 trillion economy. We are committed and will support the Indian Government achieve the goal," a statement quoting Kalyani said.

On Sunday, the defence ministry introduced import embargo on 101 items beyond a given timeline to boost the indigenisation of defence production. "This is a big step towards self-reliance in defence," defence minister Rajnath Singh said in a Twitter post.

On its part, FICCI also welcomed the Sunday announcements describing it as a "great leap forward for AtmanirbharBharat programme in defence production."

In a big push for domestic industry, the defence ministry on Sunday generated a list of 101 military items that will not be imported, with estimates that it would result in generation of orders worth Rs 4 lakh crore for Indian companies within the next seven years.

The embargo list contains major items that were imported in the past, including basic trainer aircraft, artillery, helicopters and small arms. This will open up a large playing field for domestic manufacturers that have been adding capacity for the past six years in response to the Make in India initiative.

The embargo list was announced by defence minister Rajnath Singh who said more equipment would be identified for an import embargo in due course and a coordinated mechanism for handholding of the industry by the defence services to meet requirements will be put in place.

"Almost 260 schemes of such items were contracted by the Tri-Services at an approximate cost of Rs 3.5 lakh crore between April 2015 and August 2020. It is estimated that contracts worth almost Rs 4 lakh crore will be placed upon the domestic industry within the next six to seven years," Singh said.

Among the major items identified for domestic production are wheeled armoured fighting vehicles (AFVs) with the army expected to order units valued at over Rs 5,000 crore. The navy will order six conventional submarines under its Project 75I valued at Rs 42,000 crore, a process for which is underway. The air force will order 123 of the LCA MK 1A fighter jets in the next few years that will cost over Rs 85,000 crore.

Beyond these large systems, the smaller items on the list will add significant business, especially for midsized companies that are also looking to tap the export market. These items include a range of ammunition, small arms and bullet proof equipment, besides several types of naval vessels.

In addition, the defence ministry has earmarked a part of its capital acquisition budget only for purchases from the domestic sector – starting with Rs 52,000 crore this year that will progressive increase in the upcoming budgets. The list contains items on which an embargo on imports will be implemented between 2020 and 2024.

However, sources said that ongoing initiatives like the strategic partnership model will not be impacted as they already fall under the Make in India category. Along with changes in the foreign direct investment (FDI) policy, it is expected that this decision will bring in investments by technology partners to the Indian industry to meet the substantial requirements of the armed forces, besides the potential for exports to friendly nations. The initial response of the industry to the announcement was positive.

"We can assure the defence minister that the Indian defence and aerospace industry will rise to the challenge and opportunities therein. Industry keenly looks forward to more substantive lists of key and critical products and materials which are presently being imported," Chandrajit Banerjee, director general, Confederation of Indian Industry said. Indian companies that have been creating capacity in the military sector have described the move as critical to the future.

"The growth of the domestic sector will lead to self-reliance, reduced expenditure on imports, saving of foreign currency, creating job opportunities, revival of consumption and ultimately getting us closer to the common goal of \$5 trillion economy," Baba Kalyani, CMD, Bharat Forge said.

The government's move to impose an embargo on import of 101 defence items has evoked sharp criticism from a section of unions in the ordnance factories, which feel it may only end up helping the private sector. The unions have already served a strike notice over the government's plan to corporatize the Ordnance Factory Board (OFB). The private sector, on the other hand, sees a major opportunity, as companies are ready with foreign collaborations to start production in India.

A source in Kalyani Group venture Bharat Forge said the company is planning to come up with a project to make small arms ammunition from 5.56mm calibre onwards. The company has worked out tie ups with Australian and Bulgarian manufacturers for the project and an announcement may be made soon. The group is already into making artillery guns. The 155mm howitzer made on the basis of DRDO design is due for trials, which have been held up because of the lockdown and other restrictions on account of Covid. The new policy can also bring opportunities for making naval guns and close in weapon system, said the official.

Wing Commander (retd) Rajesh Dhingra, CEO of Reliance Defence, which has a major set up in Nagpur, said, "The group already has its global tie ups, which can be taken up for production in India. Based on the technological platform available from abroad, products can be customized to Indian needs. The policy is expected to give a major fillip to the Indian industry, boosting domestic production."

Satyanarayan Nuwal, chairman of Solar Industries, which has interests in ammunition manufacture, said the policy will create space for more private players in the segment. Solar Industries is already into making Pinaka rockets, and 30mm ammunition, which are in trial stage at present. Another project on hand grenades is also underway. The policy will give an opportunity for Indian businesses to develop their own technology too, he said.

"The ordnance factories have the capacity and technology to make a number of items in the list but there are not enough orders from the Master General Ordnance (MGO) of the Army. The move to bar imports will lead to private sector companies that have got licences to make defence items moving in. With 74% FDI allowed in the sector, the companies can tie up with foreign entities and start assembling in India," said C Srikumar, general secretary of All India Defence Workers Federation (AIDEF).

The government had come up with a public procurement preference to Make in India in June 2017. Under this, 127 items were notified and another 26 were added in May 2020. The local suppliers will have to be given preference for purchases of these items.

The government should also specifically include OFB in the preference list where we have the capacity to manufacture items, said Mukesh Singh, general secretary of Bhartiya Pratiraksha Mazdoor Sangh (BPMS), the RSS affiliated union. Singh said the BPMS welcomes the decision to bar imports as it will boost indigenization.

India's new negative import list for defence systems, unveiled by Defence Minister Rajnath Singh Sunday, includes quite a few important items, such as assault rifles, snipers, light machine guns, wheeled armoured fighting vehicles (AFVs) and ultralight howitzers.

But it also misses out others like lightweight tanks and carbines, which could mean India ends up importing some products that are already available domestically, or are being worked upon.

The negative list has also thrown up some surprises, with the defence ministry stating that the Indian Air Force is looking at 123 Light Combat Aircraft Mark 1A, rather than 83, as earlier anticipated. Ministry sources said this is an indicated number for a period of five to seven years.

However, industry sources said the ministry is possibly adding up the 83 Mk1As with the 40 already ordered in the initial configuration, though they added that the figure mentioned for the deal, "over Rs 85,000 crore", is steep.

### Confusion and apprehension

Many foreign Original Equipment Manufacturers (OEMs) and even domestic players are confused on a number of issues and projects and are waiting for the finer details to come out to understand how India's new procurement process will work.

This is because many of the items manufactured in the country, including the LCA, have foreign components whose technology is not available in India.

A study of the 101 items put in the negative list shows that over one-fourth of items are already manufactured in India and have not been imported for a long time, including a number of naval vessels and systems.

The items in the negative list include those which are exclusively manufactured in India and have no foreign options, including the LCA Mk1A and Light Combat Helicopters, both manufactured by the staterun Hindustan Aeronautics Limited (HAL).

There is also an increasing feeling that the majority of the contracts will actually end up going to defence PSUs and entities, leaving little for the private players.

What Army, Navy & Air Force will get

Giving details of the break-up of funds, the defence ministry said contracts worth almost Rs 4 lakh crore will be placed with the domestic industry in the next six to seven years.

Of these, items worth almost Rs 1,30,000 crore each are likely to be procured for the Army and the Air Force, while the figure for the Navy is almost Rs 1,40,000 crore.

The Navy is likely to procure submarines, with an indicative import embargo date — the date from which the import ban is to be in place — of December 2021. It expects to contract about six submarines at an approximate cost of almost Rs 42,000 crore, the ministry said. This is the long-pending P75I project, and the front-runners to bag this contract under the strategic partnership are state-run MDL and private player L&T.

For the Air Force, the ministry has decided to enlist the LCA MK 1A with an indicative embargo date of December 2020.

"Of these, 123 are anticipated at an approximate cost of over Rs 85,000 crore. Hence, there are highly complex platforms that are included in the list of 101 items," the defence ministry said in a statement.

The ministry sources also sought to allay fears that since many systems have an embargo date of up to 2025, the armed forces will import all their demand by then, saying it is "incorrect to infer the same".

"But operational requirements will always supersede any negative list. Even in small arms, the negative list has left out the 9mm and 5.56 mm carbines, even though they are available in India now," an industry source said.

The hits

Another industry source pointed out that self-propelled guns and towed artillery are already manufactured in India, and that the mention of lightweight howitzers is a welcome step, because domestic players like Bharat Forge have already developed the systems.

Another important addition to the list is wheeled armoured fighting vehicles, which have an embargo date of December 2021.

The Army is currently looking to choose from three different vehicles, including the indigenous Tata Wheeled Armoured Protection, along with American Stryker Infantry Combat Vehicle, and Humvee.

This being put on the negative list could mean the contract will go to the Indian player, Tata.

The misses

The surprising misses from the list are the much talked about lightweight tanks and carbines.

The Army has shown interest in lightweight tanks and is involved in technical talks with Russia for its Sprut SDMI tanks. The miss is surprising because the DRDO is already working with private player L&T to make this tank, and a prototype is expected in the next 18 months.

On the procurement of carbines, the Army is likely to seal a contract with a UAE firm, much to the chagrin of domestic private firms who have come up with products of their own.

"If light machine guns and snipers can be put in the negative list, why can't other small arms?" an industry source questioned.

Items worth almost Rs 1,30,000crore for Army, Air force, and 1,40,000 crore for Navy

"Of the total, items worth almost Rs 1,30,000 crore each are anticipated for the Army and the Air Force while items worth almost Rs 1,40,000 crore are anticipated by the Navy over the same period, the Minister announced.

"The list also includes, wheeled Armoured Fighting Vehicles (AFVs) with indicative import embargo date of December 2021, of which the Army is expected to contract almost 200 at an approximate cost of over Rs 5,000 crore," he added.

Embargo on imports till 2024

Continuing to provide details, Singh said: "The embargo on imports is planned to be progressively implemented between 2020 to 2024. Our aim is to apprise the Indian defence industry about the anticipated requirements of the Armed Forces so that they are better prepared to realise the goal of indigenisation." He added, "All necessary steps would be taken to ensure that timelines for production of equipment as per the Negative Import List are met, which will include a co-ordinated mechanism for handholding of the industry by the Defence Services."

More equipment for import embargo

The Defence Minister said that more such equipment for import embargo would be identified progressively by the DMA in consultation with all stakeholders. "A due note of this will also be made in the DAP to ensure that no item in the negative list is processed for import in the future," he said.

Separate budgetary head for domestic capital procurement

In an important step, the MoD has bifurcated the capital procurement budget for 2020-21 between domestic and foreign capital procurement routes. A separate budget head has been created with an outlay of nearly Rs 52,000 crore for domestic capital procurement in the current financial year.

Echoing Prime Minister Narendra Modi's 12 May clarion call for a self-reliant India based on the five pillars, i.e., Economy, Infrastructure, System, Demography and Demand and announced a special economic package for Self-Reliant India named 'Atamnirbhar Bharat', Defence Minister also said that the "decision will offer a great opportunity to the Indian defence industry to manufacture the items in the negative list by using their own design and development capabilities or adopting the technologies designed & developed by DRDO to meet the requirements of the Armed Forces."

Prime Minister Narendra Modi in his address to the nation on 12 May 2020 had given a clarion call for a self-reliant India based on the five pillars, i.e., Economy, Infrastructure, System, Demography & Demand and announced a special economic package for selfreliant India named 'Aatmanirbhar Bharat'. Taking cue from that evocation, the Department of Military Affairs (DMA), Ministry of Defence (MoD) has prepared a list of 101 items for which there would be an embargo on the import.

This is a big step towards selfreliance in defence. It also offers a great opportunity to the Indian defence industry to rise to the occasion to manufacture the items in the negative list by using their own design and development capabilities or adopting the technologies designed and developed by Defence Research and Development Organisation (DRDO) to meet the requirements of the Armed Forces in the coming years. The list is prepared by the MoD after several rounds of consultations with all stakeholders, including Army, Air Force, Navy, DRDO, Defence Public Sector Undertakings (DPSUs), Ordnance Factory Board (OFB) and private industry to assess current and future capabilities of the Indian industry for manufacturing various ammunition/ weapons/platforms/equipment within India.

Almost 260 schemes of such items were contracted by the TriServices at an approximate cost of Rs 3.5 lakh crore between April 2015 and August 2020. With latest embargo on import of 101 items, it is estimated that contracts worth almost Rs 4 lakh crore will be placed upon the domestic industry within the next five to seven years. Of these, items worth almost Rs 1,30,000 crore each are anticipated for the Army and the Air Force while items worth almost Rs 1,40,000 crore are anticipated by the Navy over the same period. The list of 101 embargoed items comprises of not just simple parts but also some high technology weapon systems like artillery guns, assault rifles, corvettes, sonar systems, transport aircrafts, light combat helicopters (LCHs), radars and many other items to fulfil the needs of our Defence Services. The list also includes, wheeled armoured fighting vehicles (AFVs) with indicative import embargo date of December 2021, of which the Army is expected to contract almost 200 at an approximate cost of over Rs 5,000 crore. Similarly, the Navy is likely to place demands for submarines with indicative import embargo date of December 2021, of which it expects to contract about six at an approximate cost of almost Rs 42,000 crore. For the Air Force, it is decided to enlist the light combat aircraft LCA MK 1A with an indicative embargo date of December 2020. Of these, 123 are anticipated at an approximate cost of over Rs 85,000 crore. Hence, there are highly complex platforms that are included in the list of 101 items, of which details of three examples are given above.

On this announcement, Mr. Baba Kalyani, CMD, Bharat Forge said, "We at Kalyani Group, welcome the move announced by the honourable Union Minister, Rajnath Singh, this strategic step will propel the Atmanirbhar Bharat narrative and bolster Indian defence equipment manufacturing industry. All necessary steps would be taken to ensure that timelines for production of equipment as per the Negative Import List are met, which will include a coordinated mechanism for hand holding of the industry by the Defence Services. More such equipment for import embargo would be identified progressively by the DMA in consultation with all stakeholders. A due note of this will also be made in the Defence Acquisition Procedure (DAP) to ensure that no item in the negative list is processed for import in the future.

In another relevant step, the MoD has bifurcated the capital procurement budget for 2020-21 between domestic and foreign capital procurement routes. A separate budget head has been created with an outlay of nearly Rs 52,000 crore for domestic capital procurement in the current financial year.


